C2544 DECLARATIONS OF INTEREST OF MEMBERS

C2545 COMMUNITY POLICING REPORT

PCSO Beck reported speeding enforcement had taken place along Warrington Road with vehicles over the speed limit, using the true cam equipment. Asbestos had been fly tipped and an off road bike had been burnt out in Fiddlers Ferry area. Community engagement with year 6 pupils at St Vincent's School had been held. There had been no attendance at recent Police Surgery. A new Facebook page for Penketh and Cuerdley Police had been made and a leaflet drop regarding Asian gold robberies had been done. Clerk relayed a recent email received from a resident regarding speed, Cllr D Keane applauded what was being done regarding speed enforcement. PCSO Heaps to be handed over duties and speed enforcement to be at different locations, as True cam was difficult to use on dual carriageways. Clerk advised she was to chase Warrington Borough Council regarding installation of permanent speed equipment. Cllr Baker formally thanked PCSO Beck for his work within Penketh and wished him success and best wishes on his move to Greater Manchester.
