C2656 ISSUES RAISED BY MEMBERS OF THE PUBLIC.

A resident raised the issue of Precept and the amount carried forward by Penketh Parish Council and why this money was being held. A discussion was held and resident advised many projects were planned and some were still being completed, the Parish Council were aware that the pool and its surroundings needed improvements and more development was needed in the

parks with benches, pathways and play equipment, it was mentioned that the Parish could borrow for improvements rather than keep reserves, it was stated legally reserves can be kept to meet any unexpected bills or events or future planned spending and it had reduced this financial year and felt there was no need at present to borrow against any assets to raise funds for future usage. It was stated that the Parish were not in a position to borrow and 15 years ago the Parish was not as prudent or efficient as funds were needed to pay the staff salaries and there must be reserves for such situations as this. There had been two unexpected elections, two visits from travellers and the Auditor felt it acceptable to have such reserves as long as plans were in place, it was stated that match funding may be an option in the future, and it was advised that increased revenue maybe required if borrowing was to be considered as it would have to be paid back.
