C2217 ISSUES RAISED BY MEMBERS OF THE PUBLIC.

Issue raised regarding flooding Warrington Road and at power station

Resolved: Clerk to report to Warrington Borough Council.

Approximately 50-75 residents in attendance regarding a supermarket wishing to take over Sportsman Public House site. Cllr L Dirir responded that the three Warrington Borough Councillors had met with supermarket chain however no planning application had yet been received, Letters had been sent to neighbouring residents, residents asked for support from Parish Council not to have it knocked down, discussions held on action needed when a planning application is submitted. it was agreed for a public meeting to be held within next two weeks purely to discuss this matter, Clerk to advertise on social media forums, posters in Penketh baths and library to advertise when date and venue agreed.

A resident raised concerns over ongoing problems with schools, traffic and parking on Chapel Road, Cllr L Dirir responded a meeting has been set up with Head teachers, Police, governors and officers from Warrington Borough Council and a consultation is to be taken.

Penketh Court/Farnworth Road parking issues, Clerk read out update from PCSO Beck and Cllr L Dirir responded that all options are being looked at , work in progress to try and help

alleviate some of the issues.

C2218 COMMUNITY POLICING REPORT

Parking Issues Farnworth Road, Penketh

Tuesday 8th December 2015, Met with Golden Gates Steve Preston and Cath Harkin in regards to parking issues outside Penketh Court on Farnworth Road. I also posted advisory leaflets through letter boxes along Farnworth Road and Penketh Court. The leaflets included advice on parking and that we would be enforcing with Fixed Penalty Notices in the area for Unnecessary Obstruction.

Summary

Since the end of December parking issues within the area of Farnworth Road seem to have been improved I have patrolled the area. I have given advice to drivers on how they are parking and the need to consider other road users and pedestrians using the pavement. So far this month no Fixed Penalty Notices for Parking have been given. I have also spoken with local residence and business who have assured me there has been an improvement. I will continue to pay attention to Farnworth Road throughout January.

Throughout December I have patrolled Ditchfield Road at School dropping off and picking up time. I have given advisory notices for parking and also enforced unnecessary obstructions with Fixed Penalty notices.
