# **PENKETH PARISH COUNCIL - VOLUNTEER RISK ASSESSMENT**

## Adopted on: 8.7.24

### **Volunteer Responsibility**

Whilst carrying out work for Penketh Parish Council, each volunteer has the responsibility of ensuring they undertake their work considering their own health and safety and that of others around them.

As a volunteer you should not put yourself in a position that could place yourself, or others, in danger. You are under no obligation to participate or continue with any work. You are under no obligation to visit a particular site, even if organisers have suggested it. You should never undertake any work if you have concerns about your own or others' health and safety. If you have any such concerns, you should stop the work and raise these with Penketh Parish Council.

### **Risk Assessment**

Before undertaking any activities, every volunteer should consider the particular health and safety hazards associated with their individual sites and whether their individual circumstances and medical conditions expose them to particular hazards.

A table outlining generic areas of risk likely is given below. However, you should identify the potential risks specific to the activities associated with your individual sites and should think about, and apply practical precautions to minimise the level of any risks.

Volunteers should also pass on health and safety information provided to them by Penketh Parish Council to any other people helping them with related activities.

### Health and Safety Reporting

Please report any health and safety issues or concerns to Penketh Parish Council.

All accidents and incidents which could have led to harm must be reported to and recorded.
