25/26-303. Apologies for Absence

No apologies all Councillors present.

25/26-304. Declarations of Interest

Cllr Fellows declared interests as Chair of Penketh Swimming Club and private pool hirer for Puddle Penguins Swim School. Cllr Potts declared an interest in living at the same property as Cllr Fellows. No other declarations were made.

25/26-305. Minutes of Previous Meetings

Minutes of the Full Council meeting held on 13 September 2025 were approved as a correct record. Proposed Cllr Treanor, seconded Cllr Booth. Two abstentions (Cllrs Peters and Dodd).

25/26-306. Matters Arising

Minor spelling and formatting errors to be checked prior to publication.

25/26-307. Appointments, Co-options & Vacancies

The Chair welcomed new councillors Cllrs Cooper, Towell and White.

One co-option application had been received and was deferred to the end of the meeting.

The Clerk noted the election cost invoice is awaited and may require budget virement.

25/26-308. Finance

Payments for April–September 2025 were presented. Figures to be verified against invoices to avoid duplication.

An extraordinary Finance Meeting will be arranged to review budgets and spending.

Council approved temporary payment authorisation by Cllr Potts as the current signatory, pending the update of banking mandates.

New signatories will be: Clerk, Cllrs Potts, Treanor, Booth and Dodd.

Both motions proposed by Cllr Fellows, seconded by Cllr Haywood, approved unanimously.

25/26-309. Motions from Councillors

Council considered adopting *LoveAdmin* for swimming lesson management and payments.

Members noted the potential to reduce administration, improve financial tracking, and offer real-time customer access via app.
